Please be advised that our client CHASE BANK, N.A. has agreed to settle the above account in 4 payments. The minimum settlement amount is \$9000.00. The first payment is due no later than 2-28-2010 in the amount of at least \$4000.00. The remaining 3 payments are due no later than the 3-26-10 4-24-10 5-22-10 of each month in the amount of at least \$1667.00. The full amount will be applied to your account balance, when the full settlement amount is received and the funds have cleared, this account will be updated and documented as SETTLED. For the most part, collectors may not tell another person, other than your attorney or spouse, about your debt. Collectors may contact another person to confirm your location or enforce a judgment.
